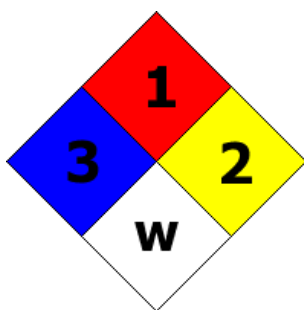

##### After inhalation:

### SECTION 5: Firefighting measures

#### Extinguishing media

**Suitable extinguishing agents:** None

**Unsuitable extinguishing agents:**

#### Special hazards arising from the substance or mixture:

Thermal decomposition can lead to release of irritating gases and vapors. Water Reactive; material will react with water and may release a flammable and/or toxic gas. This chemical poses an explosion hazard - reacts with water to form explosive hydrogen gas. May ignite or explode on contact with steam or moist air; may re-ignite after fire is extinguished.

#### Advice for firefighters:

### Appropriate Engineering controls:
